Dear Prospective Medical Laboratory Technician Student:

The application for the Medical Laboratory Technician (MLT) program at Edison State Community College is attached. It includes the list of entrance requirements for the program and an Application form. If you meet the entrance requirements and would like to turn in an Application form for the MLT program, the deadline is **December 31, 2017**. There are **no** exceptions to the date. If you are transferring from another college, unofficial transcripts must also be submitted directly to the program office. If accepted to the program, and you decide to transfer to Edison State Community College, the official transfer must occur prior to starting the program.

A selection committee will review all applications and academic records. A final decision will be made by **January 12, 2018 and applicants will receive notification the same day.**

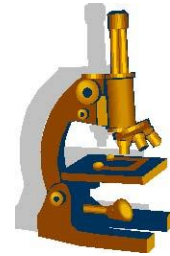
Students will be selected to the MLT program for the next cohort based on meeting the listed requirements, and with the understanding that you must achieve a grade of "B" or better in **MLT 121S** and maintain the required GPA for the remaining prerequisite courses.

Admission Requirements For Medical Lab Technician (MLT) Program

Admission to the MLT program is competitive. In addition to complying with Edison State's general admission procedures, MLT program applicants must:

1. Have successfully completed one year of high school chemistry within the last five (5) years. Applicants may take **CHM 110S, Introduction to Chemistry**, as an equivalent course.
2. Have satisfactory math assessment scores and three (3) years of college preparatory mathematics, OR a grade of "B" or better in **MTH 097D, Beginning Algebra**.
3. Have satisfactory assessment scores in reading and writing in order to be ready to take **ENG 121S, Composition I** OR successfully complete **ENG 091D Basic Writing** and **ENG 093D College Preparatory Reading**.
4. Successfully complete first and second semester courses listed for MLT degree except **MLT 121S, Introduction to Laboratory Medicine** and **MLT 135S, Urinalysis and Body Fluids**. These courses must be completed by the end of the Spring Late term.
5. Submit an MLT program application by **December 31**. Criteria for selection of applicants to be admitted to the program includes a combination of:
 - a. Satisfactory high school record, including class rank; or GED scores
 - b. ACT, SAT, or Accuplacer scores
 - c. Previous college work with **overall GPA of 2.75**
 - d. Health and Science course grades are more heavily weighed than other course grades
 - e. At the time of application, the applicant should demonstrate a clear plan to meet the requirements prior to entry to the MLT program

Applications will be available online and in the Student Services area of the Piqua Campus, at the Darke County campus, and in the MLT program office between **September 1** and **December 31, 2017**.

MLT program applications will be reviewed to select the class that will begin courses Spring Late term. All applicants will receive written notification of the status of their application by **January 12, 2018**. Students must successfully complete application requirements prior to the start of the fall MLT clinical courses.

Those selected for the program are required to have physical and immunization forms completed by a physician as well as successful background checks (FBI and BCI), and a drug screen. Applicants selected to the program will receive further information regarding these requirements.

If selected for the MLT program, coursework for semesters three and four must be taken consecutively and full-time during the day.

NOTE: Registration in and completion of support courses listed for the MLT program does not guarantee selection into the program. If there are more eligible applicants than available openings in the program, the selection will be based on GPA and highest grades in indicator courses.
