

**Agreement for the Articulation of Tech Prep Curricula  
Agribusiness & Production Systems**

Edison State Community College and Coldwater High School  
Effective August 2023

Purposes:

- To recognize the achievement of students and faculty at Coldwater High School
- To offer college credit to all affiliated students and to award credit for those who merit it
- To create a seamless pathway to college that avoids unnecessary duplication of content
- To hold both high school and college students to the same rigorous standards for credit

This agreement applies to students who have:

1. Successfully completed the applicable Agricultural and Environmental Systems career field pathway course(s),

The parties agree that:

1. College credit will be articulated for the appended college courses (Application for College Credit) for achievement of the ODE end-of-course assessment (WebXam) performance standard.
2. The instructor will submit each student's Application for College Credit to Edison State Community College by the stated deadline.
3. All students requesting articulated credit will submit an application to Edison State Community College.
4. This agreement will be valid for a period of three years from the effective date with an annual review by the Coldwater instructor and Edison State Community College program director. The parties will meet every three years to update curriculum and assessment procedures and to approve a new agreement.
5. Changes to this agreement may be requested at any time by notification from either party.
6. Credits will be added to the transcript and counted toward a pathway degree program at Edison State Community College.
