Letter of Welcome from the Program Administrator of Nursing



Program Overview

Mission

The program is dedicated to advancing the knowledge, skills, and professionalism of registered nurses. It is grounded in the principles of evidence-based practice, leadership, information literacy, diversity, and partnerships across all healthcare disciplines. Our program is dedicated to fostering lifelong learning, promoting a culture of inquiry, and demonstrating excellence in the application of evidence-based nursing practice.

Program Structure and Format

The program is designed to be completed in 4 semesters including a summer term. Students will begin with NUR 300S, Professional Nursing Concepts and will progress through each of six nursing courses as well as general and technical courses and end with NUR 490S, RN to BSN Capstone. This course can only be taken once all other nursing courses have been successfully completed.

Students are highly encouraged to complete general education courses prior to beginning the RN-BSN courses to lighten their class load while enrolled in the RN-BSN program. Any general education courses that are taken at other college or universities will be reviewed according to the Edison State process for transfer and articulation. Nursing credits from other BSN programs will not be accepted. The nursing courses are designed to be self-paced and flexible but will have assignments due regularly in each course with specific deadlines.

The program will be offered in a seminar model/hybrid format. Students will meet at the beginning of each semester for a 4- to 8-hour on-campus seminar with the remaining course instruction being offered online via Blackboard.

Accreditation Status

The Accreditation Commission for Education in Nursing (ACEN) is responsible for the specialized accreditation of nursing education schools and programs, both post-secondary and higher degree. The Commission has authority and accountability for carrying out the responsibilities inherent in the application of standards and criteria, accreditation processes, and the affairs, management, policy making, and general administration of the ACEN. ACEN is a nationally recognized specialized accrediting agency for all types of nursing programs.

Effective October 16, 2024, this nursing program is a candidate for initial accreditation by the Accreditation Commission for Education in Nursing. This candidacy status expires on October 16, 2026.

Admission Requirements and Process

Minimum Criteria for Application

To be considered for acceptance into the RN Program, students must meet the following minimum criteria for application:

1. Minimum GPA of 2.5 for all college work. If student's cumulative GPA is below 2.5, demonstrated improvement in recent academic work will be considered.
2. Graduated with an Associate Degree in Nursing from a regionally accredited institution
3. Graduated from a nationally accredited pre-licensure nursing program (ACEN or CCNE). This is specific to the nursing program and separate from the accreditation of the school or college.
4. Hold an active, unencumbered, U.S. Ohio or Multistate RN license

Criminal Record Background Check

RN-BSN students are not required to have a criminal background check prior to starting the nursing program. If Ohio and Federal background checks are required to meet the requirements of clinical agencies providing clinical experiences for the capstone course, individual students will be notified of this and asked to complete the background checks prior to beginning NUR 490S. The results will be sent directly to Edison State and any concerns regarding the results will be discussed by the program director with the student. Students who reside outside of Ohio, who engage in clinical experiences outside of Ohio, or who are licensed in any state other than Ohio may be required to have a criminal background check for another state. It is the responsibility of the student to determine the out-of-state requirements that apply to them and coordinate their compliance with those requirements while enrolled in the RN-BSN program.

Drug Screen

RN-BSN students are not required to have a drug screen prior to starting the nursing program. If a drug screen is required to meet the requirements of clinical agencies providing clinical experiences for the capstone course, individual students will be notified of this and asked to complete the drug screen prior to beginning NUR 490S. The results will be sent directly to Edison State and any concerns regarding the results will be discussed by the program director with the student

Admission Process

The RN-BSN Program admits students twice a year for a fall and spring semester start. For year two admission is projected to include 50 students. If the number of qualified applicants exceeds the limit, the applicants will be placed on a waiting list, sorted by application date and time for the following admission cycle. Applications for admission will be accepted for a January 2026 start beginning September 1, 2025, and will close December 15, 2025. For admission for an August 2026 start, applications for admission will be accepted beginning February 15, 2026, and close July 31, 2026. All students must meet with the Coordinator of Professional and Technical Pathways Advisor prior to submitting their application. Applications will be time stamped at the time of submission, and students who have met all admission requirements, including transcript delivery will receive priority admission.

Application Process

1. Submit final high school transcript or GED results (required for ESCC to confer degree)
2. Submit official college transcripts from any colleges and/or vocational schools
3. Complete Edison State Community College application for admission

4. Schedule an appointment with the Coordinator of Professional and Technical Pathways Advisor, Carin Benning, to discuss your academic and career goals and receive an application code.
5. Submit validation of current Ohio RN or Multistate RN license
6. Complete online application for RN-BSN Program

Curriculum

Curriculum Design

The curriculum plan follows the requirements set forth by the Ohio Department of Higher Education and will include a total of 122 semester hours of study. The current associate degree of nursing program at ESCC includes a total of 65 credit hours (32 hours of general education/related coursework and 33 hours of technical nursing coursework). The RN-BSN program will include an additional 30 hours of general education/related courses and 27 technical nursing hours for a total of 57 credits which will result in a total of 122 credit hours for the baccalaureate degree completion program. Nursing courses in the RN-BSN completion program will not include prerequisites, except for NUR 490S which cannot be taken until all other nursing courses are completed. The plan includes the requirements for the Ohio 36 module and in addition to the nursing technical courses, provides an even distribution of credit hours between general education and basic/related courses.

Academic Policies

The following are policies of the Edison State Community College RN-BSN Nursing Program. Students in the RN-BSN Nursing Program shall abide by these policies. Nursing Student policies are subject to change, and the Nursing Student Handbook will be revised as needed. Students will be informed of policy changes via individual emails sent through their Edison email account, through their Blackboard course, and reviewed with each class by the course instructor. It is the student's responsibility to know affiliating agency policies.

Grading Policy

Faculty evaluate students throughout the semester using a variety of methods. A satisfactory grade in the class is designated by a letter grade. A letter grade of "C" or better is passing for all nursing courses.

Evaluation methods may include the following:

- Discussion Boards
- Reflective Journals
- Case Study Reflection Questions
- Papers
- PPT Assignments
- Group Assignments
- Capstone Project
- Textbook Online Learning Activities
- Tests/Quizzes
- Video Submissions

Grades are determined by total course points. There is no rounding of points on individual assignments. A student must achieve 623.5 points to pass the class. Total course points will be rounded to the nearest whole number to determine the students' letter grade in the course. Grade Course Cut-off points are as follows: A = 743.5 B = 679.5 C = 623.5 D = 559.5.

It is expected that students will submit all written assignments on the date designated by the instructor. Grades will be available within one week of submission of the assignment. No changes in grades will be made after this time.

Continuation in and graduation from the RN-BSN Nursing Program is contingent on the student earning a grade of at least a "C" in each Nursing course and maintaining a 2.0 overall GPA at Edison State Community College.

Attendance Policy

Students are expected to be present for each campus seminar. This will be an in-person experience and will occur at the beginning of each semester. There will be an additional on campus presentation day in NUR 490S that will occur at the end of the term. It will include 4-8 hours of campus meeting time with the entire cohort and faculty member present. Since the majority of the program is offered online each course will include requirements for online participation. Students are expected to meet these requirements to be successful in each course.

Academic Integrity Policy

A student shall adhere to the Student Code of Conduct found in the Edison State Community College Student Handbook, <http://stage.edisonohio.edu/digipub/StudentHandbook/index.html>, and to behave in a professional and ethical manner while enrolled in the RN-BSN Nursing Program.

A student is expected to represent Edison State Community College and all affiliated hospitals and clinical settings in a positive manner to others, bringing issues of quality or practice forward to the faculty or Program Administrator of Nursing.

Artificial Intelligence Mixed Policy

AI May be used in some minor or non-substantive ways. The use of generative AI tools (such as ChatGPT) is permitted in the courses for the following activities:

- Brainstorming and refining your ideas
- Drafting an outline to organize your thoughts
- Checking grammar and style

The use of AI tools is not permitted for the following activities:

- Writing a draft of an assignment
- Writing entire sentences, paragraphs, or papers to complete class assignments

The use of AI tools must be properly documented and cited to stay within college policies on academic honesty. Any assignment that used generative AI unauthorizedly will be reported for academic misconduct. If in doubt about permitted usage, please ask for clarification.

The faculty abides by the college policy on Artificial Intelligence as outlined in the Edison State Community College student handbook.

Military Credit Policy

The college policy awarding Military Credit is as follows:

Edison may award credits to veterans for military training and experience. To be considered for credit, please order a copy of your **Army/AARTS** transcript, or **Sailor/Marine/ARTS** transcript or **Air Force/CCAF** transcript, and provide a copy of your DD214 to the Registration and Records office. Credit will be awarded and will appear on your transcript as military credit. There is no charge for posting military credit.

For students interested in entering the RN-BSN nursing program, the Director of Nursing in collaboration with the Nursing faculty will review all military education, training, and service of

applicants for transfer credit. Credit will be awarded to the applicant for military education or skill training that is substantially similar to the curriculum.

Retention and Progression Policy

Policies related to nursing progression and/or program completion will be identified in the RN-BSN Nursing Student Handbook which is updated at the beginning of each academic year. Policies related to student progression and/or program completion in place at the time of student entry into the RN-BSN nursing program) will remain in effect for the duration of the student's enrollment in the program unless the student fails to progress for any reason and is readmitted.

This policy clarifies that the program will not implement changes to policies related to student progression and/or program completion for those students who are enrolled in the program at the time the changes are adopted by the program.

To remain and progress in the RN-BSN nursing program, a student shall:

- Be admitted to the RN-BSN nursing program by the Dean of Health Sciences, Program Administrator of Nursing
- If a new student has an Edison GPA and it falls below 2.5 (due to taking additional classes) before they start the nursing program, the student will be dropped from the RN-BSN nursing program and will need to reapply to the RN-BSN nursing program once the student's GPA improves to a 2.5 or above.
- Students selected to start the RN-BSN nursing program who decide to withdraw before they begin the program must reapply. (This creates a "waitlist" if they keep withdrawing and asking to be added to the next semester.)
- Comply with college policies on academic standing and graduation requirements.
- Maintain a cumulative 2.0 GPA from Edison State Community College.
- Maintain no less than a "C" in each RN-BSN nursing course.
- Students who fail a nursing course may take a nursing course in the next session and retake the withdrawn or failed course the next time it is offered.
- In the case of a failure, the student must notify their advisor to request a new plan of study.
- Students may repeat a specific nursing course only once. Students receiving a grade less than a "C" in two courses, or in one course twice, are dismissed from the nursing program.
- Demonstrate safe, professional, and ethical behavior at all times.
- Maintain an active, unencumbered registered nurse license.
- Maintain Professional Standards of Behavior – See Student Conduct in the Edison State Community College Student Handbook and/or in the Edison State Community College Nursing Student Handbook.

A student may be dismissed from the RN-BSN nursing program as a result of noncompliance with any of the above.

A student who needs to withdraw from a RN-BSN nursing course due to an unavoidable/unforeseen circumstance of a serious nature which prevents completion of the course (e.g., automobile accident) and is failing at the time of the withdrawal may petition the Program Administrator of Nursing for an administrative withdrawal. If approved, an administrative withdrawal will not count as a "withdraw failing" for progression consideration.

Student Complaint Process

If a student finds herself/himself in conflict with a college process or policy—academic or non-

academic—or if the student is dissatisfied with the delivery of services provided by a college faculty or staff member, the student can submit a **Student Complaint Form** to seek resolution. Academic Complaint Procedures

If a student has a **classroom-related** problem, the student should follow these guidelines:

1. When appropriate, talk directly with the instructor and try to resolve the issue informally.
2. If dissatisfied with the outcome, complete all of the appropriate sections of the **Student Complaint Form**. Click "Submit" to email the completed form. The student will be contacted within two business days concerning an appointment with the Academic Dean of Professional & Technical Programs.
3. If still dissatisfied, the student can schedule an appointment with the Provost.

Non-Academic Complaint Procedures

If a student has a problem that is not classroom or academic related with either the college and/or with another student, the student should follow these guidelines:

1. When appropriate, attempt to resolve the complaint informally with the person who may be responsible for the dissatisfaction.
2. If dissatisfied with the outcome, complete the appropriate sections of the **Student Complaint Form** which is available on the Edison State website. Click "Submit" to email the completed form. The student will be contacted within two business days concerning an appointment with the appropriate supervisor.
3. If Steps 1 and 2 do not resolve the complaint, the student can schedule an appointment with the Dean of Enrollment Management & Student Affairs.
4. If still dissatisfied, the student can schedule an appointment with the Provost.

Based upon the nature of the complaint, the respective administrator will meet with all parties involved and will issue any decisions/actions in writing.

NOTE The basis on which a grade has been awarded may not be challenged under this complaint procedure. (See "Student Academic Grievance Procedure").

Disciplinary matters are kept confidential to the extent required by law.

Student Support Services

Academic Advising Policy

Edison offers a variety of advising options. Students are directed to the Coordinator of Professional and Technical Pathways Advising in Student Services when they apply to the college for advice on how to begin their journey at Edison. Current RN-BSN students will be served by the Coordinator of Professional and Technical Pathways Advising in the Student Affairs Office and the Dean of Health Sciences. Your advisors will make sure that you take courses in the correct sequence. They will collaborate with you and help keep you on track towards graduation.

The advisor will:

1. Indicate to advisees the advisor's office hours.
2. Help advisees develop an individualized learning plan and periodically review students' individualized learning plans/academic progress and discuss with students any problems.
3. Verify program requirements by signing the advisee's class schedule /registration forms.
4. Help advisees gain maximum use of the College resources by referring them to individuals who can help with such services as financial aid, student activities, library resources, tutoring, career placements, etc.
5. Advise students in long-range career planning.
6. Office hours for advisors are posted on Blackboard.

Library Services

The Edison State Library encourages students, faculty, and staff to explore and utilize their elaborate array of academic resources. The library houses books, periodicals, audiovisual materials, computers with access to the internet along with Edison State Databases and Ohio LINK electronic research databases. Technology Requirements

Computer Requirements

All course resources will be accessed electronically via the Blackboard Learning Management System, digital book products, or library databases. For this reason, students will need access to either a laptop or desktop computer. Computers are available on campus for student use should they not have a personal computer.

Learning Management System

Blackboard is the Learning Management System (LMS) used at Edison State Community College for the delivery of web-enhanced, web-flex, and online content. This can be accessed from the college website. Each student will have a unique login to access their course content. Blackboard has a tutorial built into the platform for students to get familiar with the LMS. The Edison State website has a FAQ section specifically for Bb and an IT Help Desk for additional questions or support.

Graduation Requirements

Completion of All Required Courses and Capstone Project Hours

In order to qualify for graduation, a student must complete all required coursework for the RN-BSN degree. Students must achieve a grade of “C” or better in all nursing courses, maintain a minimum of a 2.0 GPA at the college, and complete all required capstone hours for NUR 490S.
